Best Hot Chocolate Recipe

It's time to add a little luxury to your day with this easy to make, rich hot cocoa.

Ingredients:

- 1 1/2 cups whole milk
- 1/2 cup heavy cream
- 2 teaspoons powdered sugar
- 1/2 teaspoon of cinnamon
- 8 ounces bittersweet chocolate

Place a medium saucepan over medium heat, whisk together the whole milk, heavy cream, powdered sugar. Do not allow the mixture to boil.

Remove saucepan from the heat and stir in the chopped chocolate until melted, returning the sauce to low heat, if needed for the chocolate to melt completely. Serve warm, and top with cinnamon.
