#### Microsoft Exchange Hack

The recent breach of Microsoft Exchange accounts has impacted hundreds of

thousands of organizations across the globe. Behind the attack is Hafnium, a group that is speculated to have initiated the breach as early as January. Specifics about exposure were only recently released, however, and Microsoft is working to halt the malicious activity. Schools, hospitals, U.S.-based retailers, cities, and pharmacies were among the attack's main targets, breaching organizations' e-mail and calendar activities.


