### **#TRENDINGNOW**

Starting May 7, all U.S. travelers age 18 and older will need a **REAL ID**—or another acceptable form of identification like a passport or military ID—to board domestic flights.

Not sure if you have one? Check your driver's license for a **star in the top right corner**—that indicates it's REAL ID compliant.

The TSA warns that travelers without proper ID may face extended screening or be denied boarding. Plan ahead and visit your DMV soon to avoid travel disruptions!

### Beware of Phishing Scams Targeting Taxpayers

Even after tax season ends, scammers continue their attacks. One common method? Phishing emails that mimic IRS communications.

Here's how to protect yourself:

- Check the sender's email address. The IRS never contacts taxpayers by email, text, or social media.
- Don't click unknown links. These can download malware or lead to fake sites that steal your personal information.
- Use strong, unique passwords for any financial or government-related sites.
- Enable two-factor authentication on your tax prep and banking platforms.

If you believe you've been targeted, report the incident to the IRS and forward the email to phishing@irs.gov. Staying alert keeps your identity—and your refund—safe.
