Aphelion is an annual cosmic phenomenon during which Earth's position in orbit is at its farthest point from the sun. This year, Earth's distance from the sun will be exactly 94,507,635 miles. According to The Old Farmer's Almanac, aphelion will occur at 7:34 a.m. EDT, 6:34 a.m. CDT, 5:34 a.m. MDT, 4:34 a.m. PDT, 3:34 a.m. Alaskan Time, and 2:34 a.m. Hawaiian Time.
