PII when you head to the post office or mall to make your return. The simplest way to avoid theft is to get your hands on the original sales receipt. This typically allows for a direct refund to your credit card or offering store credit without having to swipe or present your ID. During instances in which your driver's license must be presented or scanned, monitor yourself for a while after. Your personal information is stored in the retailer's system and could be compromised in the event of a data breach.


